This seventh issue of TraHs magazine aims to analyze the different ways of understanding contemporary challenges posed by the environment and respect for the rights of nature in different countries. Thus, the articles must deal with:

- The environment as a subject of contemporary studies
- Knowledge management as a common good, public and open to all present in the proposals of the Buen Vivir ' and its results in the present;
